MEMBERSHIPS:

Annual: Open to descendants age 18 or older. Annual dues (\$70), which are not tax-

deductible, are paid each year with the first year's dues payable once

Plymouth approves the application.

Junior: For all descendants under age 18. This is a one-time membership fee, which

is <u>not</u> tax-deductible, in the amount of \$50. Members under age 18 do not receive regular Society mailings until they reach 18. They may receive educational mailings designed for their age group from time to time.

APPLICATION FEE, METHODS AND REFUND POLICY:

All applicants must pay an application fee of \$230, which is due when the application is sent to GSMD for approval. The \$230 application fee is not refundable should GSMD reject the line.

There is NO PAYMENT REQUIRED at this time.

Once we have all the required information ready to be sent to GSMD, your \$230 Application Fee will be due.

Please Note: The GSMD now requires full documentation for all of the last three generations (yourself, your parents and your grandparents) including the spouses as well as the line carriers. Specifically, this means that the General Society requires all marriages and divorces for both line carriers and spouses on those three generations.
